The Borough of Fleetwood ("Borough") reserves the right to permit, on a case-by-case basis, authorized organizations that qualify for and have been issued a Special Occasion Permit under the rules and regulations of the Pennsylvania Liquor Control Board to do so to dispense only the alcoholic beverages of beer and wine in conjunction with Borough Council approved events, in controlled environments to be held on Borough property.

Applying organizations must submit a full and complete Special Event Permit Application together with all the attachments and supplements as may be required. Special Event Permit Applications must be submitted no less than sixty (60) days prior to the Proposed Event. Please submit the following information to the Borough office for consideration:

- Any additional requests or changes to the signed permit must be approved by Borough Council.
- Applicant is responsible for garbage/debris from the event and must leave the event premises in a clean and orderly fashion.
- The Borough of Fleetwood is not responsible for any material or equipment left behind or broken during/after the event.
- Any event deemed unsafe or in violation of the Borough Ordinance or State Law will be shut down at the discretion of the Borough of Fleetwood Police Department or other emergency services.
- Applicant agrees to all terms, conditions, and time limitations that Borough Council may, in its sole discretion, impose for such use of Borough property.

Applicant recognizes and agrees that the Borough of Fleetwood requires the Proposed Event to be conducted in such a manner as to promote harmony in the area, insure domestic tranquility and be with the limits established by existing ordinances. By signature below, Applicant agrees to protect, defend, indemnify and hold the Borough of Fleetwood and its officers, employees and agents free and harmless from and against any and all losses, penalties, damages, settlements, costs or other expenses or liabilities of every kind and character arising directly or indirectly from this Proposed Event. Applicant further agrees to investigate, handle, respond to, provide defense for, and defend any such claims, etc. at Applicant's sole expense and agrees to bear all other costs/expenses related thereto, even if such claims are groundless, false or fraudulent.
