- b) Ordinance 539, Section 8 is hereby amended and shall read as follows:

SECTION 8: Any person, firm, association, corporation or other entity conducting any such sale or similar activity who shall violate or fail to comply with the provisions adopted pursuant to this Ordinance or any other rules, terms regulations or provisions adopted pursuant to this Ordinance shall be deemed to be a violation. Violator(s) shall be liable for a fine of not less than One Hundred and 00/100 Dollars (\$100.00), nor more than Three Hundred and 00/100 Dollars (\$300.00) for each violation. Each day that any violation occurs shall be deemed a separate and distinct violation of this Ordinance.

Section 3 – Severability

If any section, sentence, clause or phrase of this Ordinance is held to be invalid or unconstitutional by any court or competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Ordinance.

Section 4 – Effective Date

That this Ordinance with take effect ten (10) days after final passage.
