ORDINANCE NO. 606

AN ORDINANCE OF THE BOROUGH OF FLEETWOOD, BERKS COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 543 KNOWN AS THE "FLEETWOOD BOROUGH ZONING ORDINANCE OF 2001", AS AMENDED, BY AMENDING SECTION 505.2 e) REGARDING PARKING REQUIREMENTS FOR OFFICE BUILDINGS AND AMENDING THE OFFICIAL ZONING MAP TO PROVIDE FOR THE REZONING OF CERTAIN PROPERTIES IN THE BOROUGH OF FLEETWOOD

WHEREAS, on July 11, 2005 Borough Council of the Borough of Fleetwood enacted Ordinance No. 543, the Fleetwood Borough Zoning Ordinance of 2001 (the "Ordinance"); and

WHEREAS, the Borough Council of the Borough of Fleetwood desires to amend the Ordinance;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Fleetwood, Berks County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1. AMENDING SECTION 505.2 e) REGARDING PARKING REQUIREMENTS FOR OFFICE BUILDINGS

Section 505.2 e) of the Ordinance is amended as follows:

e) Office Buildings: One space for each 200 square feet of gross floor area

SECTION 2. AMENDMENT OF OFFICIAL ZONING MAP

The official Zoning Map of the Fleetwood Borough is hereby amended as per the attached Zoning Map, which is incorporated by reference in this Ordinance. Certain properties currently located in the Industrial (I-1) Zoning District are being rezoned to the General Commercial (C-1) Zoning District in order to effectuate the Borough redevelopment plan and the comprehensive long term plan and goals of the Borough.

SECTION 3. SEVERABILITY

If any sentence, clause section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Borough Council of the Borough of Fleetwood that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

SECTION 4. REPEALER

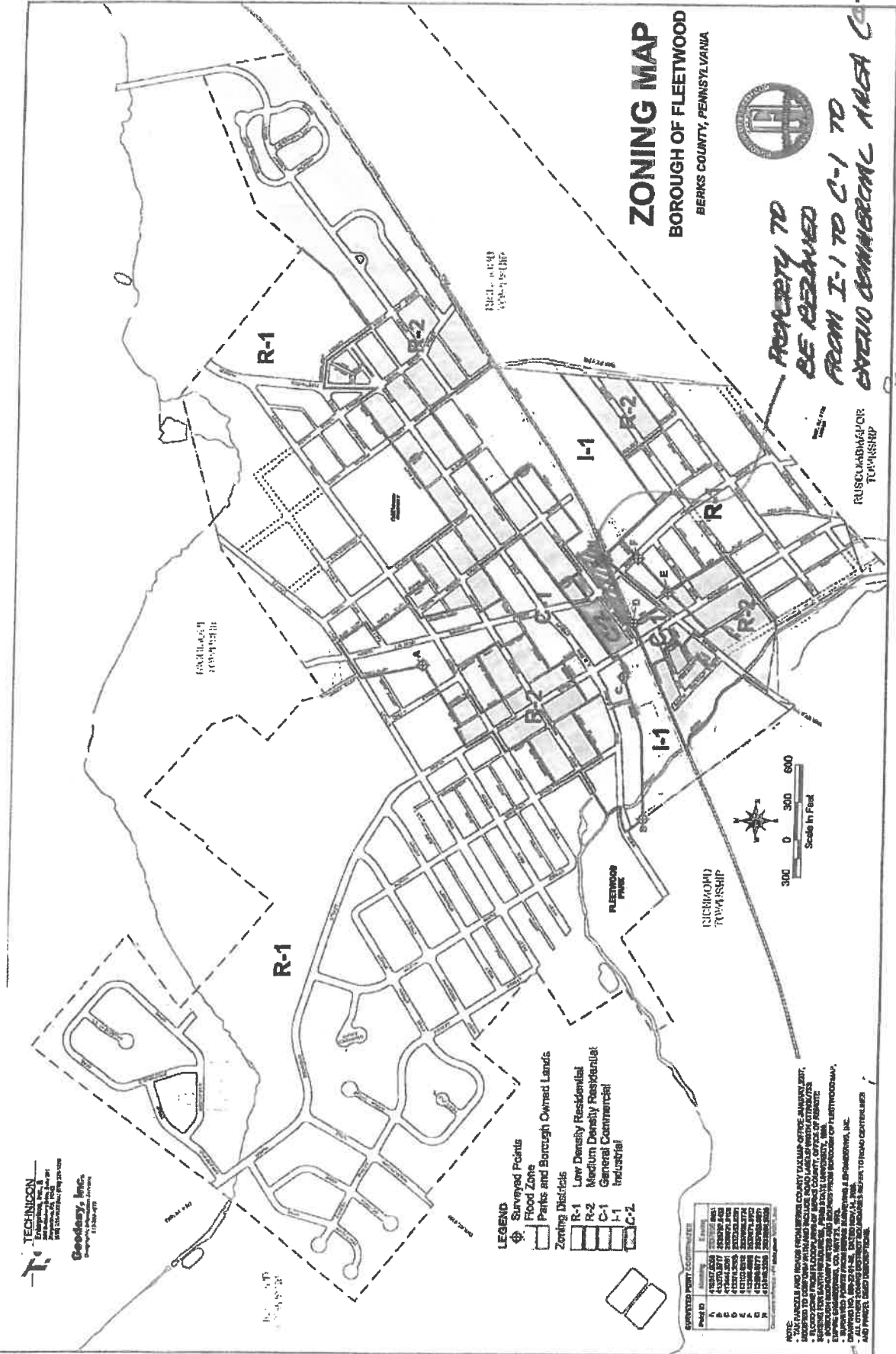
All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
